Recreation opportunities and facilities at this project have been developed and furnished by PacifiCorp (Pacific Power) as a public service.

## **CAMPGROUND REGULATIONS**

**In order to ensure the enjoyment of all recreation site guests, PacifiCorp requires observance of the following**

Camping sites are available on a first-come, first-serve basis.

**MAXIMUM CAMPGROUND STAY IS 14 DAYS.**

Checkout time is 2:00 pm.

Gate is locked 9:00 pm to 6:00 am

### **Fees**

- Campground fees include parking fees.

### **Vehicle/Parking**

- The speed limit in all recreation areas is 10 miles per hour.
- Parking is permitted only in designated areas.
- Use only designated roadways and paths.
- The use of motorbikes, ORVs, and snowmobiles is not allowed in recreation areas.

### **Rules**

- **Use or possession of alcohol or cannabis is not permitted in any PacifiCorp Energy campground or day use area.**

- **The use of unmanned aerial vehicles (i.e. drones) is not permitted in or near PacifiCorp Energy facilities, infrastructure, or recreation sites.**
- **All applicable laws regarding public safety, illegal substances, sanitation, boating, and fires will be enforced.**
- **All fires shall be confined to fireplaces installed by PacifiCorp or manufactured grills.**
- **Campfires are not allowed during Extreme fire season. Fire restrictions are posted on the Information board.**
- **Fireworks and other explosives are not permitted.**
- **The discharge of firearms or other devices discharging projectiles within or near any recreation area is not permitted.**
- Damage to trees, vegetation, or facilities is not permitted. Wildlife is not to be disturbed. No trees, dead or alive, shall be cut for firewood or any other purpose.
- Operation of public address systems or other noise producing devices is not permitted.
- Similarly, loud music or any other noise that affects others within the campground or day use area is not permitted.
- **Campsite quiet hours are from 10 p.m. to 8 a.m.**
- Pets shall be under owner's control and physically restrained by leashes no more than 6 feet in length at all times. Pet owners shall put animal waste in plastic bags and either remove it from the premises or dispose of it in trash receptacles.
- Commercial use of or offers of commercial services on or pertaining to recreation sites is not permitted without prior written permission of PacifiCorp. Commercial use includes vending merchandise, site rentals, equipment sales or rentals, advertising, providing services, etc.

- Please place bottles, cans, paper, garbage, or other rubbish or refuse in receptacles for that purpose.
- **Violators of policies are subject to removal and prosecution.**
- **Policies are subject to change without notice.**
- **PacifiCorp does not accept responsibility for the safety or well-being of recreation area guests.**
- **PacifiCorp Recreation Facilities are for use to all members of the public without regard to race, color, religious creed, or national origin, or any other status protected under applicable local, state, or federal law.**
