Enclosed please find PacifiCorp's Post-Reservoir-Dewatering Assessment Report associated with the decommissioning of the Condit Hydroelectric Project. This report is submitted in compliance with PacifiCorp's Sediment Assessment, Stabilization and Management Plan filed on March 16, 2011, as supplemented on May 5, 2011, and May 11, 2011, pursuant to ordering paragraph (M) of the Commission's *Order on Rehearing, Denying Stay, and Dismissing Extension of Time* for the Condit Hydroelectric Project, as modified by ordering paragraph (c) of the Commission's *Order Modifying and Approving Sediment Assessment, Stabilization and Management Plan* issued May 12, 2011. This report builds upon the Preliminary Sediment Behavior Report that was filed on January 24, 2012 with additional data and grading plans. The preliminary report was provided to the Washington Department of Ecology (Ecology) for consultation on December 23, 2011. The consultation record enclosed with this letter shows no comments were received from Ecology.
