A total of 350 tons of Magnesium Chloride solution was applied to CCR areas and unpaved areas of the plant. 77 tons of Magnesium Chloride was applied on 6-18-2022 to the Jim Bridger Industrial landfill ramp to the disposal area, 77 tons was applied on 7-17-2022 to the road to the coal yard, and 77 tons was applied on 8-20-2022 around the cooling towers. A fourth application is planned for the fourth quarter of 2022. The Magnesium Chloride was applied at a 30-50% solution at 0.5 gallons per square foot to the unpaved areas of the plant and roads.
