You are presently listed as an official planholder for the Emergency Action Plan (EAP) for PacifiCorp's Viva Naughton hydroelectric project. And as a planholder, you should have received our February 3, 2017 letter inviting you to this year's Table Top and Functional Exercises for our Viva Naughton hydroelectric project.

You are also listed as an official planholder for the EAP's associated with PacifiCorp's Naughton plant. The Environmental Protection Agency, through the Coal Combustible Residual (CCR) rule 40 CFR 257.73 (a)(3)(E), requires an annual face-to-face meeting with planholders to review the EAP.
