
## Environmental justice and equity

Multiple pathways to address environmental justice (EJ), including 2021 Healthy Environment for All Act (HEAL Act)

- Address policies and practices that led to health disparities
- Prevent environmental health disparities in funding
- Reduce exposure to environmental hazards within tribal lands
- Measure the accomplishments of EJ implementation

## Goal of community-engaged process that leads to environmentally just outcomes through:


- Equitable participation in decision-making
- Identification of opportunities to equitably distribute benefits
- Incorporation of EJ principles into funding decision process
- Identification of potential impacts to tribal lands and respectful consultation with tribes



## Funding opportunities

Half billion in funding available for technical assistance, planning, deployment and more

- \$275 million Clean electricity & resilient grid
- \$150.5 million Clean transportation
- \$343.5 million Building and industrial decarbonization
- \$22 million Cross cutting initiatives
- \$10 million Exclusive opportunity for tribes



## Clean electricity and resilient grid

- Solar \$195 million
  - Solar for existing buildings
  - Solar and storage
  - Large scale solar
  - Dual use solar pilot
- Grid resilience and reliability \$70 million
  - Federal and state funding for modernizing electric grid
  - Electrical grid integration and innovation
- Siting and permitting \$10 million
  - Predevelopment, land use studies and planning

## Clean transportation

- Electric Vehicle Infrastructure \$128 million
  - Initial round: \$64 million open for charging grants
  - Second round expected to open in mid-2024
- EV Incentives
  - \$22.5 million, initial RFP for open for 3<sup>rd</sup> party administrators
  - Deadline in December 2023

## Building and Industrial decarbonization

- Energy Efficiency Retrofits for Public Buildings - \$22.5 million
  - Energy and operational cost reduction through facility improvements
- Other opportunities \$75 million
  - Energy Efficiency
  - Weatherization
  - State Project Improvement (SPI)
  - Hard to Decarbonize Sectors





## Cross-cutting initiatives

- Federal Match \$10 million
  - State matching funds for federal grants
  - For clean energy research, development, and demonstration projects
- Research, Development, and Demonstration - \$12 million
  - Strategic research, development and demonstration of new and emerging clean energy technologies


