Previous Meeting Notes and Action Items

March meeting notes were approved without changes. Action items carried over appear in blue in the table above.

Decisions Made by Email Since Last ECC Meeting

The following decisions were made by email vote since the last ECC meeting. Voting records are included in Attachment 1.

- Approved Sagebrush Steppe Land Trust's annual capacity funding request in the amount of \$40,000 for the period July 2023 to June 2024.
- Approved a funding request from Sagebrush Steppe Land Trust in the amount of \$2,000 for corrective action on the Jensen deed correction.
- Approved the Station Creek project scoping report.
- Approved early release of funding for the 2023 habitat enhancement project Cub River Fish Passage and Assessment in the amount of \$15,170.

Decisions Made at This Meeting

- Approved 2023 habitat enhancement project recommendations, with approval of Reeder Ranch pending discussion of a grazing plan with the landowner.
- Approved an expenditure of \$1,000 from the Land and Water Fund for chain-of-title research on the Larsen property.

Items Added to Agenda

- Added discussion of PacifiCorp's Bear River hydroelectric project license.
- Removed the Station Creek conservation easement project scoping report.

ECC Calendar Review

- A field day was scheduled May 30, 2023, to view Bonneville cutthroat trout spawning at the Cove broodstock ponds with IDFG and tour Kackley Springs. This will replace the previously scheduled June 21, 2023 field day (now cancelled).
- Next regular ECC meeting takes place August 16, 2023.

• Prior to the August meeting, Stenberg and Jeff Lovinger, the attorney retained for the Oneida pumped storage project, will be doing one-on-one listening sessions with ECC members regarding the Bear River hydro license articles, then bring findings back to the August ECC meeting for discussion. The discussion includes possibly extending licensing period.

ECC Fund Balances

Habitat Enhancement Fund

\$779,000 – Currently in fund <u>\$353,000</u> – Outstanding obligations \$425,000 – Unobligated funding

\$325,810.44 – obligated for 2023 projects (pending)

Land and Water Fund

\$2,485,000 – Currently in fund <u>\$871,000</u> – Outstanding obligations \$1.6 million– Unobligated funding

\$445,970.01 – obligated for 2023 projects (pending)

Current Habitat Enhancement Projects

Mill Hollow - Lyman reported that \$13,000 remains in the Mill Hollow project, which is now complete. This funding will be transferred to Paris.

Elkhorn/Stauffer – Awaiting invoice.

Thomas Fork – Awaiting invoice.

Paris Stock Well #1 – Agreements are not yet in place for this project.

Hull – Funds are still remaining in this project.

Paris/Ward Brothers – Funds are still remaining in this project.

Kackley – Stenberg reported that Kackley pond is still leaking. A plan to remove it is being developed. Help may be needed during pond removal to move fish so that none are stranded.

Dip Creek – Work on this project is complete.

Davis Diversion – Awaiting invoice. There may be some touchup to gravels, etc. after this year's high water.

Boa Ogoi (Wuda Ogwa) – The Northwestern Band of Shoshone has recently invoiced for this project.

Paris Irrigation Diversion Design – An invoice may be needed for this project.

Kackley Habitat Work – Hawthorns planted during this project have been damaged by beaver, i.e., trees were girdled and bark removed.

2023 Whitewater Boater Flows

- Whitewater boater flows 1 and 2 were cancelled due to ice in the river. Flow #3 did take place.
- A fall boater flow will take place September 9 and 10, 2023. The unit under repair at Grace is still out.
- PacifiCorp has committed to boaters to find one more date for whitewater boater flows in fall 2023. Stenberg will work with PacifiCorp Engineering to schedule the remaining flow and will keep the ECC informed.

Paris Decommissioning

Paris Creek Irrigation Diversion

DeRito reported that a pre-bid tour for contractors was held Friday, May 12, with 10 contractors attending. Fencing is going in on north side. Discussions with landowners and the canal company in regard to piping, etc. are continuing.

Decommissioning Process Update

PacifiCorp is awaiting a decommissioning order from the Federal Energy Regulatory Commission (FERC). Stenberg said there has been no response from FERC since Paris decommissioning materials were filed. Similarly, there has been no response to cultural submissions made approximately six months ago. Stenberg will contact FERC for an update. If a decommissioning order comes this summer, Stenberg said PacifiCorp will go ahead and shut off the Paris plant. If not, PacifiCorp will keep it running.

2023 Habitat Enhancement Projects

The ECC reviewed recommendations for 2023 Habitat Enhancement Projects from the Grant Fund subcommittee (Attachment 2).

A vote was called to approve the subcommittee's recommendations for 2023 projects. ECC members agreed unanimously to approve all but the Reeder Ranch project. Approval of Reeder Ranch was delayed pending additional information on whether the landowner/project

proponent would be willing to agree to a grazing plan. Steven Smith will contact the landowner to inquire. An email vote will be called when this information is available.

Oneida Pumped Storage

PacifiCorp is announcing a proposal to install pumped storage hydro at the Oneida project. A Powerpoint presentation providing an overview of the project was viewed. The goal of this project is to help move the company towards net zero carbon emissions. Tax incentives for the company are greatest if this is done within the next eight years. The pumped storage project would add 200 MW to Oneida within the next 18 months through a capacity amendment to the existing FERC license (this is an application to FERC). PacifiCorp is considering applying for a license amendment to the existing Bear River license to amend the settlement agreement to add 20 years to its term. PacifiCorp will prepare a preliminary application document which will be distributed for review and would like to hold one-on-one meetings with ECC members prior to that. PacifiCorp would also need to prepare an applicant-prepared environmental impact statement (EIS), which would tier off and update the original EIS. This would include the entire Bear River Hydroelectric Project, not just Oneida. The ECC may consider letting other parties join for the next 20-year period.
