2. Unequivocal Statement of Intent:

PacifiCorp intends to file an application for a new license for the Cutler Hydroelectric Project (Project) located on the Bear River near the city of Logan in Box Elder and Cache counties in Utah utilizing Federal Energy Regulatory Commission's (FERC) Integrated Licensing Process (ILP).

3. Description of Principal Project Works to be Licensed:

Proposed project features to be licensed include a reservoir with a surface area of 5,459 acres and storage of 13,200 acre-feet, a concrete arch gravity dam that is 545-feet-long by 109-feet-high, an intake tower and two irrigation canal intakes, an 18-foot-diameter steel penstock, an 81-foot-high surge tank, two 112-foot-long steel penstocks that bifurcate at the surge tank, a brick 60-foot by 123-foot powerhouse, two turbines, two generators, two circuit breakers, two step-up transformers, and appurtenant facilities. A complete outline of all project facility dimensions is available in Section 5.2 of the Pre-Application Document.
