Opening, Review of Agenda and Meeting Notes

Frank Shrier (PacifiCorp) called the meeting to order at 9:05 a.m. and reviewed the agenda and assignments. Kim McCune communicated that she will provide the Lewis River Aquatic Funds 2014 year-end financial reporting.

The December 11, 2014 meeting notes were reviewed and approved at 9:10 am without change. McCune will follow up with Adam Haspiel to confirm if this assignment below was completed:

Haspiel: Forward the Crab Creek Acclimation Pond email to Michelle	Pending
Day at NMFS and request a formal written approval.	

McCune will finalize the December 11, 2014 meeting notes for posting to the Lewis River website.

Swift Collection Operation Discussion

Chris Karchesky (PacifiCorp) will complete the draft summary of proposed operational changes and send it out to the ACC for review prior to the February ACC Meeting. Pat Frazier (LCFRB) noted that if the write-up summarizes the points made during the December meeting, then the ACC should not have a problem with the planned outage schedule. He also added that he thought the ACC was making the right decision to cease collection during this time period.

The ACC agreed to move this agenda item to the February 12, 2015 meeting for further review and discussion.

Study/Work Product Updates

Eulachon Consultation

Michelle Day (NMFS) communicated that NMFS is working diligently on submitting its Eulachon Biological Opinion (BiOp) to the FERC. She also noted that PacifiCorp and the Cowlitz Indian Tribe have reviewed the Terms & Conditions portion.

Woodland Release Ponds

On hold for Eulachon consultation. Once the NMFS BiOp is received the Army Corps of Engineers can then issue a permit to do the work. The next step is to secure a lease agreement with the Department of Natural Resources (DNR) relating to facility in the bed and banks of the river. PacifiCorp will need to show evidence of insurance/\$3M bond. Shrier informed the ACC attendees that the DNR lease review process is a minimum of one year. This schedule would require putting off the Release Pond project for another year. Shrier also noted that the DNR will not review the lease until the BiOp is completed and all permits are in place.

Hatchery Upgrades:

Two projects remain as part of Schedule 8.7 of the Settlement Agreement.

Speelyai Hatchery Intake Modifications: In light of the recent information about a DNR lease needed for the Woodland Release Ponds Lesko will follow up with PacifiCorp's permitting department to confirm if a DNR lease is required for Speelyai Hatchery Intake and report back to the ACC and Aaron Roberts (WDFW). All remaining permits are in place. If the DNR lease is

not needed for this project it will be completed approximately September 2015. Lesko will send schedule information to Aaron Roberts (complete).

Lewis River Downstream Intake: Scheduled for completion by end of 2015 pending Eulachon BiOp.

Acclimation Pond/Crab Creek Status

On track to complete construction on Crab Creek in 2015 for operation in 2016. An approval letter from the NMFS is needed. Haspiel will forward the email in question to Michelle Day at NMFS and request a formal written approval.

Acclimation Ponds

Crab Creek: This project is slated for work to begin summer 2015.

Muddy River and Clear Creek: In mid February 2015 PacifiCorp plans to water up the ponds and confirm water quality is sufficient in the Muddy River pond; there will be a full complement of 100,000 fish and 10% of the fish will be PIT tagged.

Merwin Fish Collection Facility and General Operations (Attachment A)


During the month of December, a total of 907 fish were captured at the Merwin Fish Collection Facility; the majority (55%) of these fish were late run coho (n=501) followed by hatchery winter steelhead (n=353), and hatchery summer steelhead (n=12). One wild winter steelhead was captured and returned to the lower river. All hatchery fish and late run wild coho were transported to Lewis River Fish Hatchery and processed by WDFW. In addition, other species collected in December included resident rainbow trout (n=32) and cutthroat trout (n=8).

The Auxiliary Water Supply (AWS) system, which can boost attraction flow up to 400 cfs, was operated daily. The Ladder Water Supply (LWS) was operated daily throughout the month of December.

River flow below Merwin Dam ranged between approximately 3,260 cfs to 11,500 cfs during December.

PacifiCorp experienced operational issues at Merwin Trap due to freezing conditions the first of January 2015. Operation of the trap's lower crowder and conveyance system was suspended on January 4th due to icing. It was returned to service on January 5th. The trap is currently operating and no outages are expected anytime soon.

Upstream Transport (Attachment A)

Eight cutthroat trout greater than 13 inches were transported upstream in December. To date, a total 1,033 (452 m: 581 f) BWT winter steelhead, 9,179 early run Coho (4,788 m: 4,217 f: 174 Jack), and 42 cutthroat trout exceeding 13 inches in length have been transported and released into the headwaters of Swift Reservoir for 2014.

Swift Floating Surface Collector (Attachment A) A total of 686 fish were collected during the month of December. The majority (62 percent) of these fish were juvenile coho (n=424), followed by spring Chinook smolts (n=179), cutthroat trout (n=73), steelhead smolts (n=7), and hatchery rainbow trout (n=3). All hatchery rainbow trout were returned to Swift Reservoir. The FSC was turned off December 24th due to a malfunctioning water supply valve; the FSC was returned to service December 31, 2014 once the valve was repaired and has been running ever since.

Acclimation Ponds

Crab Creek: This project is slated for work to begin summer 2015.

Muddy River and Clear Creek: In mid February 2015 PacifiCorp plans to water up the ponds and confirm water quality; there will be a full complement of 100,000 fish and 10% of the fish will be PIT tagged.

2014/2015 Year-end Financial Reporting

McCune provided the following Lewis River Aquatic Fund year-end reporting, dated 12/31/2014 (**Attachment B**). She also noted that the \$40,000 award to LCFEG for the 2014 Haapa Habitat Enhancement Group has yet to be funded and is not reflected in the 2014 financial reporting but will be included in the 2015 reporting. In response to Pat Frazier's (LCFRB) question there will be no further contributions to the Bull Trout fund, according to the Lewis River Settlement

Agreement, Section 7.5. However, the existing balance will carry forward each year until exhausted but no further interest will accrue.


Merwin Fish Collection Facility and General Operations
