The ACC attendees reviewed Attachment D, Evaluation Criteria and discussed the following:

- The ACC must reinforce that all ACC reviewers must submit an evaluation criteria sheet (Attachment D) after pre-proposals are received.
- If criteria A (below) is met the ACC will complete the balance of the evaluation matrix document for the full proposal round.

#### A. Consistency with Fund Objectives and Priorities (Meets or Does not meet):

1. Benefit fish recovery throughout the North Fork Lewis River, priority to federal ESAlisted species (Bull Trout, Chinook, Steelhead, and Chum)

2. Support the re-introduction of anadromous fish throughout the Basin (Spring Chinook, Winter Steelhead, Coho, and Sea-run Cutthroat)

3. Enhance fish habitat in the Lewis River Basin, with priority given to the North Fork Lewis River.

- Add the following two bullets to Criteria A of Attachment D, Evaluation Criteria:
  4. Request any funding that would otherwise be required by law to perform?
  5. Maintain consistency with applicable Federal, State, and local laws and, to the extent feasible, consistent with policies and comprehensive plans in effect at the time the project is proposed.
- ACC written feedback on pre-proposals is welcome, if some of this feedback is negative but the ACC agrees the pre-proposal meets the criteria to proceed to a full proposal, the applicant must assume the risk of choosing to continue with a full proposal that may or may not receive funding.
- ACC agrees that funding design projects is allowed, providing the end result is consistent with the Settlement Agreement fund objectives and priorities
- Proposal authors are welcome to attend and observe only at the October ACC Meeting when pre-proposal discussion and decisions occurs, but cannot attend the March meeting when final funding decisions are made.
- ACC agrees all reviewers must submit an evaluation criteria document or if they choose not to, consider abstaining from voting on pre-proposals.
- ACC decided that an Aquatic Fund subgroup is not necessary at this time.
- Written comments/questions are required rather than PacifiCorp interpreting verbal ACC representative statements on a comment matrix.
- ACC prefers to fund projects that have long term benefits to fish recovery. The funding of studies or assessments, while not specifically excluded by the Settlement Agreement, are not likely to have priority over proposals that directly enhance fish habitat or fish recovery.

The ACC attendees reviewed the fund announcement cover letter titled, *Availability of Funds for Aquatic Related Project in the Lewis River Basin* and discussed the following:

• No change to LCFRB website reference this year but Steve Manlow (LCFRB) thought it was confusing and wishes to make changes to the reference in the 2019/2010 aquatic fund announcement.

### **Study/Work Product Updates**

#### **H&S Subgroup Update**

Lesko communicated to the ACC attendees that the H&S Subgroup was formed approximately 3-4 years ago to develop Hatchery & Supplementation plans and to provide adaptive management to the program. The Subgroup has discussed integrating the M&E plan activities as part of the subgroup's role. Because the Subgroup was formed by the ACC, the Subgroup is requesting input from the ACC on whether to expand the role of the Subgroup to support integration of M&E activities with overall H&S planning efforts. If the ACC decides the role of the Subgroup should be expanded, it would function essentially as a Technical Working Group for all monitoring efforts in the basin. Lesko asked that the ACC give this some thought and that we would revisit this topic at the September ACC meeting. Lesko also noted that the Subgroup is open to all Settlement Agreement signatories.

The ACC would like a summary of the different functions of each plan (M&E and H&S objectives) and how they relate to include integration and cross referencing. Lesko will provide an objective crosswalk table that was developed by the Subgroup prior to the September meeting.



#### **Upstream Transport (Attachment A)**

An additional 1,216 BWT winter steelhead were transported upstream for a total of 1,227 fish transported as part of the 2018 run year. *No winter steelhead have been capture since June 11, 2018*.

#### Swift Floating Surface Collector (Attachment A)

#### Other

#### In Lieu Fund and the University of Washington Sorel papers

Eli Asher (Cowlitz Indian Tribe) shared his concerns to the ACC regarding conflicting information he discovered between the USGS New Information Study and the University of Washington Sorel published papers and Master's thesis. Asher indicated that the USGS study did not credit Sorel and that the USGS report interprets results differently and either omits or contradicts portions of the conclusions made by the Sorel paper. Asher asked why during the In Lieu process a paper (i.e., USGS report) was provided to the ACC reporting different discussions and conclusions than the Sorel papers and thesis. Asher provided Lesko written copies of both reports identifying specific changes and comments by Asher. Asher and the ACC attendees requested Dr. Al-Chokhachy (USGS) address the ACC about discrepancies or whether the Services are already digging into the matter.

Rudy Salakory (Cowlitz Indian Tribe) expressed that he would like to see a narrative developed to re-establish trust and how this discrepancy came to be.

Lesko informed the ACC that he will discuss with Todd Olson (PacifiCorp) regarding the ACC request and concerns expressed by Asher and Salakory (including the written comments provided by Asher).


