#### **Opening, Review of Agenda and Meeting Notes**

Erik Lesko (PacifiCorp) called the meeting to order at 9:05am and also reviewed the agenda. An update on Lewis River Hatchery broodstock and screw trap will be provided at the end of the meeting.

Lesko also reviewed the October 11, 2018 meeting notes. The meeting notes were approved with clarifying changes at 9:10 a.m.

#### **Public Comment**

None

#### 2018 Winter Steelhead Adult Trap Efficient Report (ATE Report)

Chris Karchesky (PacifiCorp) reminded the ACC attendees that the draft Adult Trap Efficiency (ATE) Report was emailed to the ACC November 5, 2018 for a 30-day review and comment period. Comments are due by December 5, 2018.

The Monitoring & Evaluation Plan describes the need for an evaluation of the collection efficiency of the Merwin Dam adult fish trap for upstream migrating winter Steelhead, spring Chinook and Coho salmon. This current report focuses on results evaluating collection efficiency of blank wire tag (BWT) hatchery Winter Steelhead. The ATE Report is also under review with the H&S Subgroup who are meeting November 29 2018. The Subgroup will make its recommendation on how to proceed with future ATE studies at Merwin Dam at the December 13, 2018 ACC Meeting. A decision regarding this topic is requested from the ACC no later than December 13, 2018.

#### **Study/Work Product Updates**

#### **H&S Subgroup**

The Subgroup is currently working on take tables for the HGMPs and will be discussed at the H&S Subgroup meeting on November 29, 2018. The Subgroup will be working on the Annual Operating Plan during the morning session. After the morning session, recommendation(s) regarding the ATE report will be discussed and provided at the next ACC meeting for review and approval.

#### **Bull Trout Subgroup Update; Tom Wadsworth (WDFW)**

Wadsworth informed the ACC attendees that the BT Subgroup will finalize a report that synthesizes known information for Lewis River bull trout and send to the ACC for review in December 2018. A tentative date for a presentation on this report to the ACC is the January 10, 2019 meeting. Wadsworth also noted that they wish for the Forest Service to review the report before it is sent to the ACC.

#### In Lieu Update

Lesko informed the ACC attendees that the Services requested an additional extension from the FERC to December 4, 2018.

#### **Acclimation Pond Removal (Crab Creek)**

Ruth Tracy (USDA Forest Service) expressed to the ACC that they informed PacifiCorp they want the gabion wall at Crab Creek removed. PacifiCorp is currently working on a memorandum of understanding that they will present to the Forest Service.


#### **Merwin Fish Collection Facility and General Operations (Attachment A)**

During the month of October, a total of 1,977 fish were captured at the Merwin Dam Adult Fish Collection Facility. The majority of these fish were coho (1,340-68%) of which 584 were coho jacks. The spring Chinook run concluded in early September. A total of 2,106 spring Chinook returned to Merwin Trap in 2018.

No major outages occurred in October, the Merwin Dam Fish Collection Facility ran continuously during the month.

River flow below Merwin Dam remained near the minimum flow requirements of 1,200 cfs through October 15, 2018, and 2,500 cfs beginning October 16, 2018 through the end of the month.

#### Discharge, cubic feet per second



Karchesky (PacifiCorp) informed the ACC that an outage is scheduled for Merwin Fish Collection Facility the week of November 26<sup>th</sup>, 2018 for routine maintenance.

#### **Upstream Transport (Attachment A)**

Nine Blank Wire Tag (BWT) winter steelhead were transported upstream above Swift Dam in December 2017. Two additional fish were transported earlier in the fall for a total of 11 BWT steelhead collected and transported in fall/winter 2017. An additional 1,216 BWT winter steelhead were transported upstream for a total of 1,227 fish transported as part of the 2018 run year. *One hatchery Winter Steelhead was captured in October 2018*.

A total of 700 adult spring Chinook have been transported upstream as part of the 2018 run. Of these fish, 329 were transported from the Merwin Dam Fish Collection Facility with an additional 371 fish being transported from the Lewis River Hatchery. Transported upstream were 177 females, 491 Males, and 32 jacks. By the end of June, all surplus adult spring Chinook previously being held at Lewis River Hatchery had been distributed into the upper basin or used as brood stock.

By the end of October 2018, 1,916 adult early-run coho (1,029 male/579 female) had been transported upstream along with 308 wild jacks. Fifteen (15) adult late-coho along with 13 wild jacks had also been transported upstream. Through the end of October, a total of 35 returning PIT-tagged early coho have been observed at Merwin Trap. All of these returning PIT tagged coho were tagged in spring 2017 and 2018 at the Swift Floating Surface Collector before release into the Lewis River below Merwin Dam. Six of the returning PIT-tagged coho have been observed as adults while the rest have been jacks/jills.

#### **Swift Floating Surface Collector (Attachment A)**

The Swift Reservoir Floating Surface Collector was returned to service on October 15, 2018. By the end of the month, 242 fish had been collected. The majority (98%) of these fish were outmigrating juvenile coho (n=156) and spring Chinook (n=78).

Karchesky (PacifiCorp) also noted that since early November, collection numbers have increased at the FSC and there are currently 200 - 250 fish per day being collected. Most of these fish have been juvenile Coho.

It was also noted the in order to install the false floor (discussed at the October 11, 2018 ACC meeting), the FSC will need to be off. Currently, this work is scheduled to occur from January 15 – January 30, 2019.

#### Other

*Hatchery Broodstock* - Aaron Roberts (WDFW) informed the ACC that the Lewis River Hatchery currently has 192 late-Coho HOR (males & females) and 60 late-Coho NORs. He said hatchery collection was far behind the expected return. Roberts also noted that they experienced electrical issues at the hatchery trap but they were back on line at 10:00am November 7<sup>th</sup>. They need to collect approximately 500 pair for the Lewis on-station program.

Screw Trap – Lesko informed the ACC attendees that the screw trap was installed on October 15 near the Lewis River golf course downstream of Merwin Dam. The purpose of the trap is to look at the migration timing and distribution of spring Chinook smolts released at Lewis River Hatchery. The trap was averaging about 180 smolts per day during the first few days after the volitional release period started at the hatchery. However, numbers dropped off quickly and are now averaging less than 10 per day. PacifiCorp recommends removing the trap next week due to the low catch rates.


