Kirk Naylor (PacifiCorp Energy) called the meeting to order.

Annual Report and Plan

Comments on the annual report were received. Group discussed whether any of the maps could be removed to reduce costs of preparing and producing the report. Generally the thought was that maps enhance the understanding and should be retained. Use of tables and maps should replace extensive text where possible.

Elk-Equestrian Study Update

Emmerson met with the Clark County Saddle Club and the Mt. St. Helens Back County Club to discuss their potential assistance in gathering elk responses to recreation users at Saddle Dam Farm. Emmerson also met with the PacifiCorp communication department to assist with design of a survey postcard. Postcard would also contain a website link for those that want to complete the survey electronically.

Reservoir Drift

Logs are available for any who want them. The Forest Service put a bid out for logging companies to pick up the logs. The insurance requirements result in too high of costs so the Forest Service can't move the logs either. Kirk Naylor is working on the insurance requirements with the risk group at the company. Mason Bruce and Girard will begin eagle surveys in December.

PacifiCorp identified a trespass where two mature big leaf maple trees were cut on PacifiCorp land by an adjacent landowner to enhance their view. The TCC discussed the fact that the trees were cut on leased lands (Lake Merwin Cacmpers Hideaway) and that this effectively violated the lease, as well as the WHMP. Funds collected should reflect the value of the lost habitat, not just the stumpage value. It was suggested that compensation will be put in the Wildlife Habitat Management Plan account and the TCC can determine how those funds are used to enhance habitat.
