On September 2, 2015, PacifiCorp submitted Scoping Document 1 for the Weber Hydroelectric Project (Project), FERC Project No. 1744. SOLICITATION OF SCOPING COMMENTS FOR WEBER HYDROELECTRIC PROJECT RELICENSING

On May 29, 2015 Pacificorp, the owner and operator of the Weber Hydroelectric Project, located near the mouth of Weber Canyon, on the Weber River, Utah, approximately 9 miles southeast of Ogden, Utah, filed a Notice of Intent 1o seek relicensing of the Weber Project, and also submitted the required Pre-Application Document and request to use the Alternative License Process (ALP), with the Federal Energy Regulatory Commission (FERC). On August 13, 2015, FERC granted PacificOrp's request to use the ALP.

Under the ALP, PacifiCorp will prepare an Applicant Prepared Environmental Assessment (APEA) and license application for the Weber Project, and expects to file these documents by May 31, 2018. FERC will prepare a separate and independent environmental assessment (EA) or an Environmental Impact Statement (EIS) in accordance with the National Environmental Policy Act (NEPA).

On September 2, 2015, PacifiCorp filed Scoping Document 1 (SD1), pursuant to the relicensing process for the Weber Hydroelectric Project. Based on all written comments received on SD1, a Scoping Document 2 (SD2) may be issued. SD2 will include a revised list of issues, based on the scoping sessions. The Scoping Documents and associated scoping meetings will satisfy the NEPA scoping requirements, irrespective of whether an EA or EIS is issued by FERC.

The purpose of this notice is to inform you of the opportunity to participate in the scoping process through reviewing of SDI and attending the upcoming scoping meetings and site visit identified below, and to solicit your scoping comments. Please file comments using the Commission's eFilling system at http://www.ferc.gov/docs-filling/efiling.asp. Commenters can also submit brief comments using the eComment system at http://www.ferc.gov/docs-filling/ecomment.asp. You must include your name and contact information at the end of your comments. In lieu of electronic filing, please send a paper copy to: Secretary, Federal Energy Regulatory Commission, 888 First Street, NE, Washington, D.C. 20426. The first page of any filing should include docket number P-1744-039. The deadline for filing scoping comments is November 3, 2015.

Scoping Meetings and Site Visit

In collaboration with FERC, PacifiCorp will hold two scoping meetings, one in the daytime and one in the evening, to identify the scope of issues to be addressed in the APEA/EA. The daytime scoping meeting will focus on resource agency concerns, while the evening scoping meeting is primarily for public input. All interested individuals, organizations, tribes, and agencies are invited to attend one or both of the meetings, and lo assist in identifying the environmental issues that should be analyzed in the APEA/EA. A site visit will also be held.
