Subject: Weber Hydroelectric Project (FERC Project No. 1744)

Filing of Notice of Intent to File an Application for New License

and Pre-Application Document

Dear Secretary Bose:

Pursuant to the regulations of the Federal Energy Regulatory Commission (FERC) for the Alternative Licensing Process (ALP), 18 CFR §§ 4.34, 5.5, and 5.6, PacifiCorp hereby submits a Notice of Intent (NOI) to File an Application for New License, and a Pre-Application Document (PAD) for PacifiCorp's Weber Hydroelectric Project, FERC Project No. 1744 (Project), located on the Weber River in northeastern Utah. PacifiCorp requests to use the FERC ALP to provide the framework for its consultation with agencies, tribes, and other stakeholders for the Weber Project relicensing. This request has the support of key stakeholders (see enclosure, *Interested Party Meeting Notes and ALP Process Support*). In accordance with 18 CFR §§ 5.3, PacifiCorp has also provided a copy of the Weber Project Communication Protocol, drafted and reviewed with the assistance of interested parties to the Weber relicensing process, and has published notice of the filing of the PAD and related NOI, and of the request to use the ALP. This notice was filed concurrently with the PAD and NOI in the Ogden Standard Examiner, a daily newspaper of general circulation in each county in which the project is located.

In conjunction with this e-Filing, PacifiCorp is requesting that the FERC designate PacifiCorp as the Commission's non-federal representative for carrying out informal consultation, pursuant to Section 7 of the Endangered Species Act and Section 106 of the National Historic Preservation Act. Also included with this e-Filing is a draft notice for future publication by FERC in the Federal Register.
