Public Utility Commission of Oregon Staff (Staff) appreciates PacifiCorp's presentation and information relating to customer-driven renewables provided at the 2019 IRP Public Meeting held on Sept. 27-28, 2018. Staff offers the following comments requesting further clarity and additional information so as to more meaningfully participate in this process.

Customer-drivenrenewables: PacifiCorp's customer-drivenrenewableresources assumptions (starting on slide 100) present the company's best estimates as to what policies will be made in the future. Oregon Staff believes this to be an appropriate planning decision, even when there is considerable uncertainty; even when the company doesn't know which particular cities and companies will opt for renewables, it's reasonable to believe that some will. PacifiCorp need to plan for a system that meets those demands.

Oregon Staff though contrasts that with Navigant's Private Generation Study presented at the August PIM. Here, the consultant assumed that all existing policies will sunset, and that no new private generation policies will be enacted. As noted in an earlier Public Input Form (August #2), Oregon Staff believes this to be inappropriate, especially given how important a driver to private generation Navigant believes policy to be. In light of PacifiCorp's decision to forecast policies about future customer choices, Oregon Staff believes that the company should use in its base-case Navigant's presented high-scenario of private generation.

PacifiCorp Response:

For the Private Generation Study, Navigant assumes that existing policies will remain. PacifiCorp is not planning to use Navigant's high case in the base case. PacifiCorp will however, conduct a high private generation sensitivity.
