Commission Staff Feedback for PacifiCorp 2021 IRP: Public Interest Meeting #7 (Jan 29, 2021)

On December 18, 2020, WECC released its Western Assessment of Resource Adequacy Report. The Report made several findings as well as three specific recommendations: 1) Planning entities and their regulatory authorities should consider moving away from a fixed planning reserve margin to a probabilistically determined margin. As variability grows, a dynamic planning reserve margin will better ensure resource adequacy for all hours.; 2) Planning entities should consider not only how much additional capacity is needed to mitigate variability, but also the expected availability of the resource. Understanding the differences in resource type availability is crucial to performing resource adequacy studies.; 3) Planning entities should coordinate their resource planning efforts on an interconnection-wide basis each year to help ensure they are not all relying on the same imports to maintain resource adequacy. This coordination will help subregions make assumptions about import availability in the context of the entire interconnection. The Wyoming Office of Consumer Advocate strongly believes that these recommendations should be incorporated into RMP's 2021 IRP analysis. The link to the WECC Resource Adequacy Report
