# 2021 IRP File Date Extension



- PacifiCorp plans to seek approval, as applicable, from its state commissions to extend the 2021 IRP file date from April 1, 2021 to no later than September 1, 2021.
- The 2020 All-Source Request for Proposals (2020AS RFP) is on-track to have a final shortlist by June 1, 2021 which can have implications on the resource plan, both near-term and long-term.
- Extending the file date would allow the results of the 2020AS RFP to be accounted for in the current planning cycle.
- In addition, as indicated in the prior public-input meeting, PacifiCorp has continued to make progress on addressing modeling functionality and performance issues associated with implementing new and advanced modeling software, however, has not been able to successfully complete any model runs to establish resource portfolios and to evaluate costs and risks.
- This extension would enable PacifiCorp to overcome these challenges while allowing sufficient time for stakeholder review and input.

# Next Steps



- State commission filings to be made February 12, 2021.
- PacifiCorp proposes to pause its previously scheduled public-input meetings and resume in April 2021 to allow time for modeling work.
- Additional public-input meetings to be scheduled up to the extended file date as proposed below:
  - April 22-23, 2021 – Public-Input Meeting
  - May 27-28, 2021 – Public-Input Meeting
  - June 24-25, 2021 – Public-Input Meeting
  - July 29-30, 2021 – Public-Input Meeting
  - *August 12, 2021 – Public-Input Meeting (if needed)*
  - No later than September 1, 2021 – File 2021 IRP
