


Closing the Loop from Last Meeting

What is net metering?


Net Metering: a billing credit from your utility company for power you generate. If your usage exceeds what you generate, you are billed on the "net" - i.e., the difference between what you use and what generate

- Energy exported to grid is offset 1 for 1 with energy charges
- Energy credits can be banked for future use and expire in April



Net Metering

- First interconnection in 2000
- Energy is credited 1 for 1
- Significant growth in adoption
- 18,976 customers participating
- 197 MW of nameplate capacity
- 2.9% of customers on net metering




Oregon Solar Incentive Program

- Authorized by House Bill 3039 in 2009
- Incentive to spur the solar installation market
- 714 participants
- Volumetric Incentive Rate
 - Paid for all solar generation
 - Varies by install date and location
 - Range from 20.7¢ to 65.0¢ per kWH
 - \$5,892 average annual payment
- \$10 per month Solar Meter Charge
- \$3.2 million annual cost to customers
- 15-year contract first one expires in August 2025



Net Billing in Utah and California

- Both programs began in 2020
- Legacy net metering program closed to new applications
- Exported energy is credited at a value of exports (presently at 6.9¢ per kWh in Utah)
- Adoption has remained stable





- Implementing a successor program for the Oregon Solar Incentive Program by August 2025
 - Evaluating Net Metering and exploring alternative customer generation programs
- Continuing and improving upon outreach with interested parties



- Language is clear in explaining the key components required by HB2021


Achieving Our Priorities:


