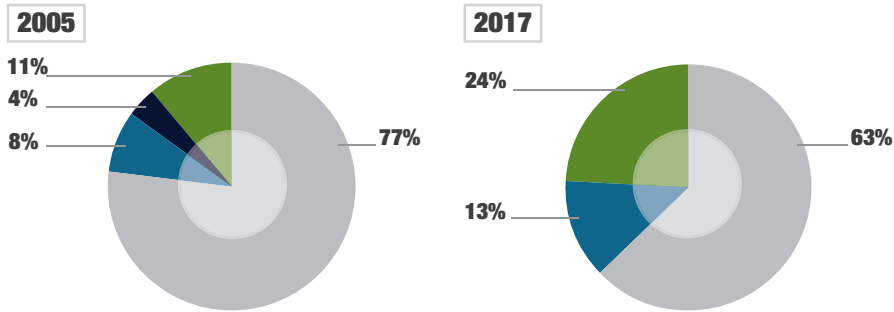




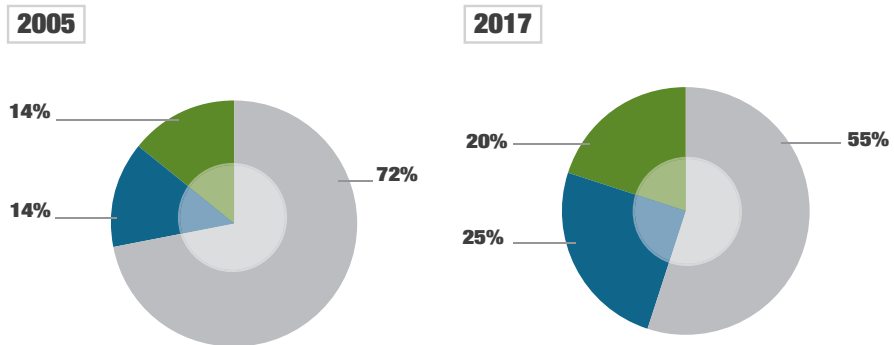
## PACIFICORP SUSTAINABILITY REPORT

### Net Generation

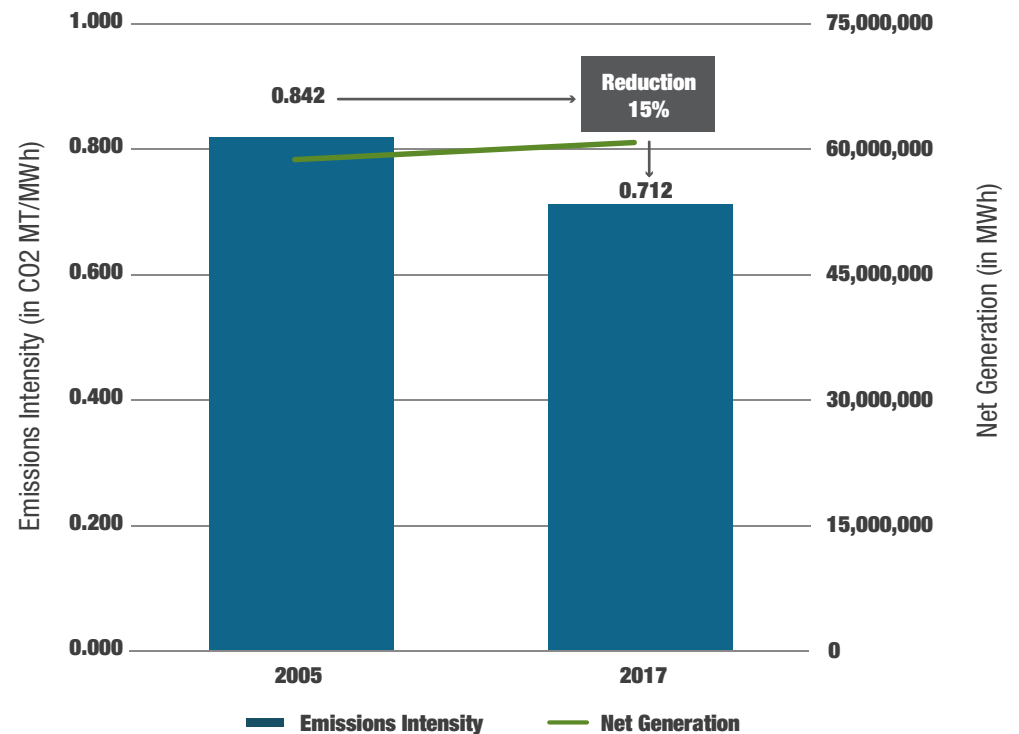


### Generation Capacity
